

Hereditary peers' by-election, June 2021: result

In the by-election following the retirement of the Countess of Mar, 317 valid votes were cast. All members of the House of Lords, who had taken the oath and were not on leave of absence, disqualified or suspended from the service of the House, were eligible to vote.

On the first count, of the 10 candidates, 10 received one or more first-preference votes. There were 6 transfers of votes. The votes for the final three candidates were:

Lord Londesborough 147 votes Lord Meston 80 votes Lord Chorley 50 votes

The successful candidate was therefore Lord Londesborough.

Overleaf are details of the votes cast for each candidate. The left-hand column lists all candidates. The penultimate row shows the total number of votes. The last row shows the number of votes required for a candidate to be elected—i.e. half the total (rounded up if necessary).

Note on the voting system

- The election was conducted using the alternative vote system (also known as preferential voting).
- Under this system, voters rank in order as many candidates as they wish.
- Initially only first-preference votes are counted.
- If the vote for any one candidate equals or exceeds the votes for all the other candidates combined, that candidate is elected.
- Otherwise the votes for the candidate or candidates with fewest votes (or, in the event of a
 tie, fewest first-preference votes) are transferred to whichever of the continuing candidates
 is marked by that voter as their next available preference, and the votes thus transferred are
 added to the first-preference votes of those candidates. The process is repeated until one
 candidate has as many votes as all the other remaining candidates combined.
- Any ballot on which no further preference is marked is non-transferable.

The poll was conducted using electronic means and the count was conducted by Civica Election Services (formerly Electoral Reform Services).
