## **Business Planning 2011/12**

*"Take note" paper by the Strategy, Planning & Performance Co-ordinator Office of the Chief Executive* 

#### Purpose

1. This paper sets out the proposed timetable for corporate and departmental business planning for 2011/12.

### Actions for the Board

2. The Board is asked to take note.

### Background

3. In previous years the House Service has set its business objectives and then requested the necessary funds. The advent of the Savings Programme means that this planning round is different: we are setting the financial envelope first and then drafting business plans in the light of that decision.

### Outline

- 4. Assuming that the timetable below is acceptable to the Board, the OCE will prepare an outline corporate business plan for consideration at the December Management Board meeting.
- 5. We propose to engage with Business Management Directors, via the Resource Management Group, to develop departmental business plan templates in more detail.
- 6. The OCE will propose to BMDs that departmental business plans should:
  - Be shorter than in previous years.
  - Be based on the new strategy for the House service, developing a "line of sight" that links high-level corporate goals to personal objectives, via departmental and directorate objectives.
  - Be focused on the department as a whole, rather than being a collection of directorate-level plans (departments are encouraged, of course, to develop plans at a directorate or office level).
  - Reflect the commitments departments have made to reduce costs via the Savings Programme.
  - Incorporate performance indicators that they use currently and/or intend to develop for use in 2011/12.

#### Risk

7. OCE is aware that more work needs to be done on updating corporate risks in the light of the risk management project, and to identify new risks arising out of the new strategy. Separate proposals will be brought to the Board on this matter.
